Documentation Required for a Tourist Visa

Photocopies of supporting evidence must be submitted with your application. Originals of the supporting documents should be brought when lodging the application and shown if requested. Our service standard for processing the application is 5 working days.

- Application Form 48R

- Application fee: **S\$150** (cash, cheque or credit card (Visa and MasterCard only).
Note: NETS is not available. Please allow 5 working days for cheque clearance
- One passport-sized photograph (please attach to the form)
- Your Employment Pass/ Dependent Pass/ Social Visit Pass/ Work Permit/ Student Pass or IC Card (if applicable). Please provide a copy
- Your current passport. Please provide a copy of the personal identification page(s) of the passport (that is: name, date of birth, passport validity and signature page)
- You are required to demonstrate that you intend a genuine visit to Australia, have the funds to support your visit for the length of stay, and intend to leave Australia at the end of your visit. Documents to support these factors may include, but are not limited to, the following:
 - A letter (not your leave application) from your employer stating the length of employment, job title, salary, the leave period approved (specify dates) and whether leave is paid or unpaid. The signatory's name and title should be clearly spelt out. If you intend to travel for an extended period, the letter should state whether your job is available to you on return (business registration, if applicable)
 - If you are a student, a letter from your school
 - Your flight itinerary (not ticket – we recommend you do not purchase a ticket before the application has been decided) and accommodation booking. Please provide a copy
 - Evidence of funds – for example: the original bank savings book or bank statements. These must show a history of transactions over a period of time and must be current immediately prior to the date of your visa application. Please provide a copy
 - If being supported by family/friends in Australia, an undertaking from this person concerning the nature of support to be provided, for example: accommodation, food, finances and any other relevant issue. If applicable include a copy of your birth and/or marriage certificate to show the relationship to your family member.
